Bureau feels preparation of leaflets as requested in relet has merit, and you are authorized to duplicate sufficient copies on commercially obtained paper to have posted on various bulletin boards where they might be seen by majority of students at San Diego State College. It is hopeful this action will have desired effect of dissuading would-be new recruits from membership in YSA.

Bureau sees no advantage to be gained from mailing copies of leaflets to YSA members as outlined in relet. Accordingly, this should not be done.

Insure leaflets are reproduced in such a manner that Bureau is fully protected as source of leaflets. Promptly report any information obtained indicating effect produced by appearance of leaflets.

NOTE:

As result of recent decision by YSA to admit homo- sexual members, San Diego has prepared two leaflets which clearly invite "gay set" (homosexuals) to membership in YSA and provide first names and first initial of last names, and telephone numbers of YSA activists who can be contacted for further information. San Diego requested authority to mail, through YSA P.O. Box, copies of leaflets to the six YSA activists involved. San Diego also requested authority to have copies of leaflets posted on various bulletin boards on campus of San Diego State College. Posting of the leaflets on campus to dissuade new membership in YSA has merit and being approved. Idea of mailing leaflets to specific YSA members appears to serve no useful purpose and authority not being granted. Leaflets will not be traceable to Bureau.

Enclosed for the Bureau are two copies of proposed leaflets.

The Young Socialist Alliance (YSA) in San Diego has a chapter at San Diego State College consisting of approximately 15 members more or less at any one time. This group holds meetings for themselves and the Socialist Workers Party (SWP) on campus.

On 1/6/71, a letter from [Redacted] of the National Office of the SWP, to all members of SWP and YSA entitled "Report on Membership Policy Given to Policy Committee of SWP [Redacted]" refers to a change of policy allowing homosexuals to be considered for membership in SWP and YSA. The report specified that they should be taken into the party and membership divided on an individual basis.

San Diego received a copy of this letter to all members from [Redacted] on 1/15/71.

It is noted that [Redacted] a member of YSA in San Diego, was recently arrested on a felony charge for committing an abnormal act with a Negro male in a public place.

In view of the letter submitted to all members and this arrest of a YSA member for committing this felony, which will possibly receive considerable publicity at the time of her trial, San Diego feels that at this time some counterintelligence action might be warranted against YSA.

The leaflets will be mailed to them in care of YSA, Post Office Box in San Diego. Inasmuch as the letter described above went to all members of the YSA and because the San Diego Office will not use the home addresses of these individuals, there is no chance that this counterintelligence activity will in any way compromise the identity of [REDACTED].

Bureau authority is also requested to have copies of these leaflets posted on various bulletin boards where they will be seen by a maximum number of individuals who might otherwise become involved with YSA.

San Diego will reproduce these leaflets in such a way that they can in no way be traced to the FBI and Bureau is assured that no embarrassment to the Bureau will result from this counterintelligence activity.

A. POTENTIAL COUNTERINTELLIGENCE ACTION

The People's Commune housing a group of individuals who print the "San Diego Street Journal", an underground type newspaper in San Diego, continues to be an appropriate target for counterintelligence operation. The Bureau has been previously advised that the commune was located in the 3200 block of Second and Third Avenues in San Diego and that they had moved to 2412 J Street, San Diego. They have now moved out of 2412 J Street and are living at various locations.

The Young Socialist Alliance (YSA) at San Diego State College (SDSC) in San Diego is allied with the Student Mobilization Committee (SMC) in planning anti-war and anti-establishment activities. This group appears to be in the process of becoming more militant and there have been some indications that they might be gathering, or attempting to gather, weapons. These two groups have good potential for counterintelligence operation.

The Students for a Democratic Society (SDS) in San Diego remain as a potential for counterintelligence action as it appears that certain elements in this group are attempting to start SDS organizations in junior colleges in San Diego. This group will be carefully watched for opportunities to interfere with this activity.

The Movement for a Democratic Military (MDM) at 519 Freeman Street, Oceanside, California, is also a radical anti-establishment organization which continues to be a target for potential counterintelligence action. It is noted that PATRICIA SUMI, one of the organizers of MDM, recently travelled to North Vietnam and Moscow in the company of ELDRIDGE CLEAVER.

B. PENDING COUNTERINTELLIGENCE ACTION

At the present time [REDACTED] is becoming more closely associated with individual members of the SDS group at UCSD in San Diego in an effort to tone down and modify their activities more in line with that of the old Communist Party which has seldom been involved in activities such as bombings and violence.

The San Diego Office continues to furnish the San Diego Police Department information at any time such information can result in the arrest of members of the various groups listed above where they become involved in illegal activities. Through close cooperation with local law enforcement intelligence agencies, local law enforcement is kept advised of planned activities of these groups and many acts contemplated by them can thus be stopped. For example, during a recent demonstration in San Diego, radical members had planned to take some action against flags located along the route of their march. As the result of intelligence information furnished to local law enforcement agencies, officers were stationed in such locations that they could observe and take action should any of the flags be defaced. As a result the radicals were completely frustrated stating that they could not plan anything without law enforcement officers knowing in advance.

Violent counterintelligence action such as breaking windows in homes and offices has been taken against radical groups in San Diego for some time. For example, the People's Commune at 2412 J Street, recently vacated by them, has nearly every window broken. As a result of this type of activities these groups have a difficult time renting space for offices or for communal type living. In view of this counterintelligence activity being taken against these groups by unidentified individuals, the San Diego Office is not planning this type of counterintelligence at the present time, but continues to watch for opportunities to frustrate these groups through the passing on of intelligence information and through possible means which might interfere with their financial situation which at the present time is at a low ebb.

Any specific counterintelligence action to be taken by the San Diego Office will be submitted to the Bureau for approval prior to taking such action.

C. TANGIBLE RESULTS

At the present time in San Diego it appears that groups are having a difficult time rallying support for their activities by any except hard core radical elements. A "stop the pig" demonstration on 10/3/70 directed against the San Diego Police Department was only able to get slightly more than 200 persons. It is expected that demonstrations in the future will rally more persons due to the backing received from students now assembled at the various colleges. The People's Commune has been forced to vacate their communal type residence through counterintelligence action which has made it difficult for them to satisfy their landlords. YSA has been held to a small group of individuals at SDSC. The SMC is having financial difficulties as are the other groups, and it appears that action taken against these various radical groups in San Diego by law enforcement and other unidentified persons has kept these groups in a state of confusion and financial disaster.

San Diego will continue to be alert for instances where counterintelligence action could possibly aid in the destruction of these new left groups.

A. POTENTIAL COUNTERINTELLIGENCE ACTION

The Students of the Independent Left (SIL) is no longer active at colleges in San Diego. Two of the leaders of this group have become involved in the publication of a weekly underground newspaper called The San Diego Street Journal. They are _____ and _____

The SDS in San Diego has been temporarily at a low ebb in membership and activity. These groups, including the Weatherman faction, are presently attempting to stage a comeback and become organized in the San Diego area.

A chapter of the Young Socialist Alliance (YSA) exists at San Diego State College (SDSC).

A group called the Student Mobilization Committee has been active at SDSC in anti-war and Vietnam moratorium activities.

New groups such as the Movement for a Democratic Military (MDM), the Green Machine, and people associated with underground type newspapers published for the military service such as Duck Power and Attitude Check have recently become active in San Diego.

Persons involved in resistance and anti-draft type activities continue to operate in the San Diego area.

All of the above organizations represent a potential for counterintelligence action at this time.

B. PENDING COUNTERINTELLIGENCE ACTION

The commune publishing the San Diego Street Journal and persons publishing another underground newspaper called the San Diego Door to Liberation have been subjected to considerable harassment during the past six months. This includes breaking into both of their offices with considerable destruction of machines and equipment, items being thrown or shot through windows and doors of offices of the newspapers and the commune itself, the theft of 2500 copies of the San Diego Street Journal, the burning of an automobile parked in front of the commune, and many other harassing incidents such as threatening telephone calls, theft of records, etcetera. As a result of this action, the San Diego Street Journal and The Door have published a large number of articles which were critical of the San Diego Police Department for not solving crimes against these groups and members of the groups have contacted the California Department of Justice and other law enforcement agencies in an attempt to force the police department to solve these harassing incidents. In view of these incidents, it does not appear that counterintelligence action against this particular group at this time would be wise due to the possibility of becoming involved with other incidents that have taken place.

The SDS, including the Weatherman faction are attempting to become organized in the San Diego area but at this time are ineffectual and are causing little or no trouble in the community. The San Diego Office is attempting to heavily infiltrate these groups with informants at the start of their organizing activity and should they progress to the point where they begin to assert their influence on schools and the community, the San Diego Office will recommend counterintelligence action to be taken against these groups. Several copies of a Reader's Digest story called "SDS: Engineers of Campus Chaos" are available in the San Diego Office and Bureau authority will be requested, at the proper time, to mail copies of these pamphlets to individuals who appear in sympathy with SDS groups in order to weaken the influence of these groups.

The San Diego Office will recommend counterintelligence action to be taken against MDM, Green Machine, Duck Power and Attitude Check at such time as these groups appear to be successful in their organizing efforts.

Considerable investigation is being conducted in San Diego with regard to resistance and anti-draft groups, and at the present time a massive interview program is in progress to interview everyone connected in any way with the harboring of individuals absent without leave or in a deserter status, as well as the interview of any military man who has been in such a status who might be able to furnish information of an evidentiary nature. Individuals who are interviewed have been advised that the FBI is conducting an investigation with a view toward prosecuting individuals involved in conspiracy to harbor deserters, commit acts of sedition, or to violate the law in draft resistance work. This has had considerable affect on persons who were previously openly active in this type of activity.

C. TANGIBLE RESULTS

Due to the considerable harassment of the San Diego Street Journal, The Door, and the communes in which individuals who publish these papers live and resulting publicity by what is believed to be right wing organizations, most of the individuals involved in radical movements have ceased to operate effectively in San Diego.

It was noted recently that a sign had been posted on a GI coffee house called "The Waiting Room" in downtown San Diego stating, "Deserters and AWOLs not welcome!". It is believed that the posting of this sign by a group normally dedicated to assisting this type of an individual has been caused by active investigation in the case entitled, "THE RESISTANCE".

As the result of a rally held by the Green Machine in Oceanside, California, on 12/14/69, the City of Oceanside has mailed a bill for \$29,000 to [REDACTED] of San Diego.

is for extra services provided by the city such as law enforcement officials, overtime pay, etcetera. The City of Oceanside at first refused a permit for the rally and parade, but were forced by court order to allow the rally and it is the position of the city that extra expenses for such a rally not budgeted must be taken care of by someone other than the taxpayer.

Members of the Green Machine have been living in a house in Vista, California, where they have had meetings in a large four car garage after failing to rent a place for a GI coffee house due to resistance by city officials. These individuals have now been ordered to vacate that residence and garage by the owner because of the considerable activity of law enforcement officers who are interested in meetings and gatherings at that residence.

San Diego will continue to be alert to situations which lend themselves to counterintelligence activity, however, it is felt that during times when activity by new left and radical groups are at a low ebb, excessive counterintelligence activities could create sympathy, financial support, and an aggravated attitude which might increase their activities.

A. POTENTIAL COUNTERINTELLIGENCE ACTION

A school called the Exploring Family School has been started in San Diego which is run by individuals involved in anti-government and anti-military activity in San Diego. The purpose of the school is to teach revolutionary ideas to children at a young age. [redacted] previously mentioned as a target of counterintelligence action, is active in the forming and operation of this school. A letterhead memorandum is being submitted to the Bureau describing the school and Bureau authority will then be obtained to have local authorities take the necessary action to close the school.

B. PENDING COUNTERINTELLIGENCE ACTION

The action against the Exploring Family School is pending at the present time and will continue after letterhead memorandum submitted to the Bureau fully describing the school.

C. TANGIBLE RESULTS

Airline companies were contacted on Bureau authority to prevent Young Socialist and Socialist Worker's Party member (SWP) [redacted] from using a half fare ticket to attend the SWP national convention. *SD 10/30* information has been received confirming that this caused him trouble on his trip.

A. POTENTIAL COUNTERINTELLIGENCE ACTION

[REDACTED], San Diego [REDACTED] is being considered as a target for the Counterintelligence Program. [REDACTED] is becoming more and more active in various groups and demonstrations throughout the San Diego area. He appears to be vulnerable in several areas and immediately upon determining what counterintelligence action would be most effective, Bureau approval will be requested.

B. PENDING COUNTERINTELLIGENCE ACTION

At the present time evaluations are still being made concerning the Bureau approved dissemination of the information that [REDACTED] was present during the arrests of two Selective Service violators. Tangible results thus far observed appear in the following section of this letter.

C. TANGIBLE RESULTS

[REDACTED] and [REDACTED] both former members of Students for a Democratic Society (SDS) in San Diego, have reportedly moved to the Los Angeles area along with approximately four other individuals who formerly belonged to the same group. It is pointed out that the parents of both of these individuals were recipients of the Bureau approved letter concerning their activities. Although it cannot be definitely

established, it is felt that their reported move to the Los Angeles area, where their parents reside, could logically be the result of the exposure of their activities in the San Diego area.

On 2/14/69, information was received that marijuana and dangerous drugs were being utilized at 4029 Dove Street, a "crash pad" operated by Message Information Center (MIC). This information was furnished to the San Diego Police Department in view of the fact that it involved a violation of local law. The police department subsequently raided the house but were unable to effect any arrests or locate any drugs on that particular day. As a result, however, the owner of the house was confronted by unknown individuals and apprised of the activities which were being conducted at the house. As a result, the owner reportedly got "fed up", had the house completely demolished, and sold the property. Thus, the "crash pad" at 4029 Dove Street no longer exists.

[REDACTED] has reportedly been completely ostracized by members of MIC and all of the other individuals throughout the area who are associated with this and/or related groups. This seems to be occasioned by the fact that he is generally considered to be a police informant [REDACTED]

D. MISCELLANEOUS

No substantial amount of public source information appears to be available concerning [REDACTED] San Diego [REDACTED]. At this time it is not felt that any counterintelligence action can be taken against [REDACTED] without the possibility of jeopardizing the security of one or more informants. Therefore, no counterintelligence action is being requested against [REDACTED] at this time. His activities, however, are being followed closely and when an opportunity presents itself, appropriate counterintelligence action will be requested.

They have also been mailed anonymously to the leaders of the Students for a Democratic Society (SDS) at San Diego, including [redacted] San Diego [redacted] and [redacted] San Diego [redacted]. Copies have also been anonymously distributed to the office of "The Indicator", a radical student newspaper at the University of California at San Diego. One copy has also been mailed to [redacted] from San Diego to a Chicago address.

To date no positive results have been observed concerning the above mentioned distribution. Informants contacted in this regard have advised that no information of any type has been received by them concerning any leaflets distributed relative to SDS.

San Diego will continue to follow this matter and, in the event any information of a positive nature is obtained, will immediately advise the Bureau and Chicago.

A. POTENTIAL COUNTERINTELLIGENCE ACTION

[redacted], San Diego [redacted], is being considered for a target of the Counterintelligence Program. In this regard the Los Angeles Division has been requested to furnish San Diego all available public source information in that Division regarding this individual. Upon receipt of this information, appropriate action will be decided upon and Bureau approval will be requested.

[redacted] San Diego [redacted] a participant in Students for a Democratic Society (SDS) at San Diego State College, is also being considered for additional counterintelligence action.

At the present time the Message Information Center (MIC), San Diego 100-14427, appears to be operating a "crash pad" at 4029 Dove Street, San Diego, which seems to be under the direct control of [redacted] San Diego [redacted]. Attempts are being made to determine the identity of the owner of the residence at the above address, after which appropriate letters will be prepared and submitted to the Bureau for approval. These letters, it is anticipated, will be anonymously sent to the occupants of the houses surrounding the "crash pad" as well as to the owner of the house occupied. They will be in the nature of protesting the occupancy of the house for the purpose of harboring AWOL persons and related activities.

B. PENDING COUNTERINTELLIGENCE ACTION

Evaluation of the mailing of the authorized letters containing a copy of the "Teaspoon Door" is continuing. The only tangible results thus far determined appear in the following section of this letter.

The pamphlet prepared and forwarded by the Chicago Division has been placed anonymously on prominent bulletin boards at San Diego State College and University of California at San Diego. They have also been mailed anonymously to the leaders of SDS at San Diego including [REDACTED] San Diego [REDACTED] and [REDACTED], San Diego [REDACTED]. Copies have also been anonymously distributed to the office of "The Indicator", a radical student newspaper at University of California at San Diego. One copy has also been mailed to [REDACTED] from San Diego to his Chicago address.

C. TANGIBLE RESULTS

Although it cannot be definitely established, it is felt that as a result of the information furnished the St. Louis Division concerning [REDACTED] followed by an article subsequently appearing in "The Maneater", a weekly publication at the University of Missouri on [REDACTED] [REDACTED] cancelled his scheduled lecture at the University of Missouri on [REDACTED].

It is also noted that this information created a disturbance in the minds of some prominent individuals in the St. Louis Division. It is reported that these individuals are bringing this information concerning [REDACTED] to the attention of the State Legislators to point out to them the type of individuals considered for lecture engagements at the University of Missouri.

[REDACTED] San Diego [REDACTED] is no longer living with [REDACTED]. Although he has returned to San Diego State College, no information has been received indicating any current activity in SDS by [REDACTED] subsequent to the receipt of the letter mailed to his parents. It is too early to state that [REDACTED] has been neutralized concerning his activities, but, as of this date, he appears to be definitely curtailed in these activities.

As a sidelight to the authorized mailing of the letters containing the "Teaspoon Door" to the parents of four of the key activists in the San Diego area, the presence of the "Teaspoon Door" circulated on the San Diego State College campus has mushroomed into several complaints being received at a local television station. This television station has a program called "Action Report" during which complaints received from the general public are aired and appropriate action requested. This program in turn complained to the San Diego Police Department regarding the "Teaspoon Door" and this complaint ultimately resulted in the Editor of the "Teaspoon Door" being arrested on contributing and pornographic charges. It is felt that the fervor created concerning the "Teaspoon Door" may be directly related to the mailing of these papers due to the fact that the complaints received by the television station follow the receipt of the letters within two days.

D. MISCELLANEOUS

Information regarding the cohabitation of [redacted] and [redacted] was not furnished to the San Diego Police Department in view of the fact this condition no longer exists. [redacted] since his return from Christmas vacation, is reportedly living with another male student also from the Los Angeles area.

[redacted], upon whom counterintelligence action has previously been requested, has now made a complete reversal in his radical activities. He is still under close scrutiny and, in the event that his new or subsequent activities are appropriate for counterintelligence action, an appropriate request will be submitted to the Bureau.

The New Haven Office has advised that no public source information concerning [redacted], son of [redacted] is available. Therefore, no dissemination of public source information to Assemblyman [redacted] is possible at this time.

For the information of the Bureau, the name T. E. ELLIS is completely fictitious. The [redacted] and has absolutely no traceable connection to the FBI.

In paragraph 2, second sentence "college students" has been changed to "militant revolutionary." The fourth sentence of paragraph 2 has been terminated after the word "establishment" and the fifth sentence has been omitted.

The original information concerning the illegal cohabitation between [redacted] and [redacted] was received from [redacted] and, according to this informant, the situation which exists between [redacted] and [redacted] is common knowledge among the members of SDS at San Diego State College. It is not believed that the furnishing of this information to the police department would in any way jeopardize the informant.

In addition, when [redacted] was interviewed concerning the Chicago riots, he was located at the home of [redacted]. It was noted during attempts to locate [redacted] at this time that he has also listed his home address as being identical with the known address of [redacted]. At the time of the interview, Agents observed both [redacted] and [redacted] at [redacted] residence and it appeared as though they were at that time living together.

Concerning the request for sending an anonymous letter to the parents of [redacted] this letter is presently being prepared and will be forwarded to the Bureau for approval at an early date.

He is also on the staff of the San Diego Free Press, a local underground newspaper. In addition, he is a "draft counsellor" for the Peace and Freedom Party.

[redacted] has reported that [redacted] is extremely concerned over being surveilled by the FBI and is of the opinion that his phone is being tapped, microphones are installed in his residence, and that his every move is being observed.

It is felt that a "small push in the right direction" would cause [redacted] to be so disturbed as to cause him to portray an individual with obvious paranoid tendencies. Once this becomes obvious, it is felt that such actions on his part would completely neutralize him in his several leadership capacities.

The proposed letter is signed with the name "T. E. Ellis, Post Office Box 12186, San Diego, California." Prior to authorizing these letters, you are to advise whether that name and address is fictitious and whether you have made prior arrangements with the Post Office for the use of this box. In addition, your proposed letter should be changed in the following respects:

Paragraph two, second sentence, "college students" should be changed to "militant revolutionary"; end the fourth sentence of paragraph two after "establishment"; delete the fifth sentence of this paragraph as it has been used extensively by the Bureau and could serve to identify the source of the letter.

Relet also recommends that information be supplied to the San Diego Police Department relating to the illegal cohabitation of [REDACTED] and [REDACTED]. Your letter, however, fails to establish how this information was developed or to advise as to whether the furnishing of such information to the police department would jeopardize any sources of your office. Before taking any action in this regard, furnish the Bureau all details of the situation existing and how you obtained this information.

You also suggested an anonymous letter be sent to the parents of [REDACTED] telling them of this situation. Before authorizing any such letter, you should furnish the Bureau with a copy of the letter you propose to send.

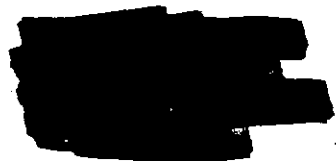

I am writing to you with a great deal of reservation and hesitation over a situation in which your son (daughter) has become involved at San Diego State College. I too have a student at San Diego State and can therefore appreciate your concern over what our children, grown up as they may be, may become involved in once they leave our protective custody and launch out on their own, so to speak.

Your son (daughter) has joined and is active in a New Left movement known as the Students for a Democratic Society (SDS). This organization is basically a college student group. It draws its supporters from a motley variety including beatniks, hippies, disenchanted intellectuals, young faculty members and other students on the campus. The movement is held together by bitter hatred of what is called "the establishment," that is the institutions of democratic society. The SDS is a highly militant

A. POTENTIAL COUNTERINTELLIGENCE ACTION

1. An informant in Students for a Democratic Society (SDS) at San Diego advises that [redacted] (one of the leading SDS activists in San Diego) is living out of wedlock with a female named [redacted] (LNU) who has attended several SDS functions. After fully identifying [redacted] (LNU), recommendation will be made that the Bureau authorize the mailing of a letter to [redacted] parents advising them of this situation. The letter could be written from a rejected suitor.

B. PENDING COUNTERINTELLIGENCE ACTION

Consideration will be given to purchasing a subscription for the "Teaspoon Door" (local underground newspaper) for delivery to [redacted] at the Philosophy Department, University of California at San Diego (UCSD). It is felt that this could result in some embarrassment to [redacted] among his colleagues at UCSD. After receipt of several issues, recommendation will be submitted to the Bureau for approval to write an anonymous letter to the Chancellor at UCSD protesting [redacted] regular receipt of the publication. This letter could be written by the father of a coed at UCSD.

C. TANGIBLE RESULTS

Reprints of "Campus or Battleground?" were mailed to appropriate faculty and staff members of San Diego area colleges and universities. Impressions made on each recipient are of course difficult to assess at this time.

the organization advocated using sabotage and explosives, if necessary, to destroy the institutions of the United States, particularly educational institutions. The Students for a Democratic Society has clearly stated that the first step in destroying our democracy is to destroy our schools and institutions of higher learning.

It is within your power to help defeat the taking of this first step by outlawing this organization on your campus by revoking the charter of this organization on the San Diego State College campus and by denying the use of campus facilities to this organization. It is sincerely hoped that the Board of Trustees will act against this organization on a state-wide basis. There is no question whether the Board of Trustees has the power to take this action. The only question is "Does it have the courage?"

I do not feel that I should sign this letter because I have a son in attendance at San Diego State College and the attitude towards the Students for a Democratic Society on this campus has been so permissive that members of the organization, whom I consider to be irresponsible and dangerous revolutionaries, would not be above taking violent measures against my son.

Dear Dr. Love:

I have shared with you the deep desire to protect the freedoms which have greatly contributed to the development of our democratic form of government in the world today, but we must agree that these freedoms cannot be unlimited. The libel laws, our nation's sedition statute, for example, express limitations which are necessary to prevent one man's or one group's freedoms from injuring others in our society.

More and more today we are assailed by anti-intellectual, simplistic sloganism which lifts all restrictions on freedom of expression and equates the incitement of destruction of democratic procedures and institutions with the plea for justice in our democracy.

In about 1965 there appeared on the scene in the U. S. a new organization, Students for a Democratic Society, which appeared to have as its goal the betterment of our educational institutions and a better communication between the students and the administration of these institutions. Many chapters of this organization obtained charters and were allowed to use campus facilities for their activities. We have observed changes in this organization. Former students no longer associated with any educational institution have stayed on in this organization, negating the "student" portion of the organization's name, and more and more, the organization has made its position clear as opposing traditional democratic processes, making a mockery of the "democratic" portion of the name.

The current character of this organization has now been fully revealed at its June 1968 national convention at Michigan State University, East Lansing, Michigan. At this meeting,

Postal Inspector's Office, San Diego, California, should be advised so that appropriate action could be taken to investigate this matter further.

2. The underground newspaper "The Teaspoon" and "The Door" does not list members of its editorial staff in each weekly publication. Postal Inspectors should be contacted to determine whether a newspaper complies with the law if it fails to list names of its editorial staff and, if not, appropriate action should be taken to insure that this matter is thoroughly investigated by appropriate authorities.

C. TANGIBLE RESULTS

There have been no tangible results that can be attributed to this Program to date. Pursuant to referenced Bureau letter, information is being set forth concerning the following categories:

1) False Allegations of Police Brutality

The San Diego Division has no instances on record concerning police-student encounters during demonstrations. During the limited number of previous demonstrations in the San Diego area, the students and participants have taken deliberate steps to avoid confrontation with police. Thus, there are no resulting allegations of police brutality by New Left students.

2) Immorality

Investigation in individual New Left cases has revealed a limited number of instances indicating that possible immorality involved.

In the case of [REDACTED] member of Students of the Independent Left (SIL) at University of California at San Diego (UCSD), investigation revealed that MOORE was evicted from the dormitory at UCSD for entertaining women in his room.

Separate investigative cases are open concerning two other SIL members at UCSD, [REDACTED] and [REDACTED]. Investigation in each of those cases has revealed that these two individuals, while not married, are residing together in La Jolla, California.

[REDACTED] a self-admitted communist and alleged former W.E.B. DU BOIS Club member, and [REDACTED] SCHWARTZ, both alleged to be connected with SIL at UCSD, were refused admission by the University during the fall of 1967 because of participation in the manufacture of LSD.

3) Action by College Administrators

There have been no instances of violent actions on the part of students on any campus in the San Diego Division. There have been no overt attempts by militant minority elements to take over or to disrupt college campuses in this Division. During the "Ten Days of Protest and Resistance, April 21-30, 1968" New Left students in the San Diego area decided against participation in the "International Student Strike" because they decided there was a general apathy and lack of enthusiasm and interest in this movement in the San Diego area.

San Diego college administrators have, however, as a general rule been rather permissive in allowing extra freedom to New Left groups. There is only one instance in which a college administration took a firm stand in not allowing an activity promoted by New Left students.

Communist Party member [REDACTED] of the Southern California District CP at Los Angeles, California, was invited by a group of students at Grossmont Junior College, San Diego, to speak to students and to participate in a debate with a member of the John Birch Society. College administrators ruled that [REDACTED] would not be permitted to speak. Students have filed a petition at San Diego, California, which is now in litigation. This petition seeks to over-rule the action of the college administrators and allow [REDACTED] to speak at Grossmont Junior College.

The San Diego Division is constantly on the alert for any information which will assist in embarrassing and exposing New Left activists. In future investigations of individual New Left activists, this Counterintelligence Program will be constantly kept in mind and investigation will be made with a view in mind to expose these individuals at every possible opportunity.

The San Diego Division has three organizations which are involved in New Left activities, Students for a Democratic Society (SDS), Students of the Independent Left (SIL) at University of California at San Diego, and The Resistance. In addition, there are numerous New Left activists who are unaffiliated with any organization.

Following is a list of potential counterintelligence action which could be effectively directed against New Left activists in the San Diego area:

(1) Expose the activities of these individuals to their employers, parents, school officials, and other appropriate individuals and organizations.

(2) When incidents arise which are potentially embarrassing to these activists, this information could be furnished to news media locally through reliable sources for publication. Copies of these news articles could then be sent to parents, employers, school officials or other appropriate parties.

(3) Subversive publications or other embarrassing paraphernalia could be mailed or delivered to professors who are faculty advisors to New Left organizations at the various colleges. This type of counterintelligence activity could also be directed against student activists at their places of employment, and could result in much embarrassment to them and exposure of their activities and interests.

4) Where opportunities arise, a program of misinformation could be directed against New Left organizations and individuals so as to confuse them and disrupt their activities. For example, where events are planned, notification that the event had been postponed or cancelled could be given to New Left leaders and members.

45) Under proper circumstances, New Left leaders and activists, with the cooperation of local police agencies, could be arrested for illegal activities, and thereafter could be exposed through reliable news media.

46) Where warranted, a concentrated counterintelligence program could be directed against leading activists.

The San Diego Division believes that utilization of the above counterintelligence methods should result in exposure, disruption, and neutralization of the efforts of the New Left activists in the San Diego area.
