Wounded Knee Leadership Cases

Please prepare a prosecutive summary of the evidence available to prove the charges against Russell Means, Dennis Banks, Clyde Ballcourt, Stanley Holder, Carter Camp and Leonard Crow Dog (the so-called leadership figures). It would be appreciated if you would furnish a copy of such summary to the Criminal Division and to the United States Attorney for the District of South Dakota.

II. ELEMENTS OF CIR STATUTE

In reference to crimes committed on an Indian Reservation, a crime to be cognizable under the laws of the United States must have been committed by an Indian or against an Indian on an Indian Reservation under the jurisdiction of the United States.

General laws of the United States as to punishment of crimes committed anyplace within the sole and exclusive jurisdiction of the United States, except the District of Columbia, shall extend to Indian country except as to crimes which are expressly provided for. These general laws shall not extend to crimes committed by one Indian against the person or the property of another Indian, nor to any Indian committing an offense in Indian country who has been punished by the local law of the tribe or to any case the exclusive jurisdiction over which has been secured to Indian tribes by Treaty stipulations.

On October 16, 1973, STANLEY D. LYMAN, Superintendent, Pine Ridge Indian Reservation, advised that Pine Ridge, South Dakota, is the headquarters of the Oglala Sioux Tribe and the Pine Ridge Indian Agency is located within the established boundary of the Pine Ridge Indian Reservation. He advised that most of the land within the Pine Ridge Indian Reservation is owned by the United States Government, either outright or intrusted for the Oglala Sioux Tribe or individual Indians.

On March 8, 1973, Mr. [redacted] [redacted] Bureau of Indian Affairs, Pine Ridge, South Dakota, advised that the area known as Wounded Knee, South Dakota, is located within the boundaries of the Pine Ridge Indian Reservation, which is Federally owned property.

III. BACKGROUND AND NARRATIVE OF OFFENSE

During the weekend of January 13 - 14, 1973, a unity conference was held between Mexican-American and American Indians at Scottsbluff, Nebraska. In the early morning hours of January 14, 1973, Scottsbluff police officers responded to disturbance complaints at a Scottsbluff motel and this resulted in the arrest of RUSSELL MEANS and [redacted]. After being placed in the Scottsbluff cell, MEANS was observed to have a weapon in his pocket, which police officers had not searched at the time of his arrest.

On January 15, 1973, Chicanos and Indians protested the arrest of MEANS at the Scottsbluff Police Department and later that evening the Junior High School was firebombed causing minor damage. Shortly after the firebombing, a vehicle was stopped and two persons were arrested for possession of destructive device, materials for making a Molotov cocktail. Later that evening, reports were received that AIM and Chicanos were making firebombs in the Guadeloupe Center on East Eighth Street, Scottsbluff, Nebraska. It was learned that [redacted]

JOHN ARBUCKLE, well known Nebraska AIM leader, and several other Indians, had purchased gasoline in a five-gallon can in Alliance, Nebraska. The vehicle in which they were riding was stopped by Scottsbluff County sheriff's officers and officers of the Bureau of Alcohol, Tobacco and Firearms. Observed in the vehicle were a five-gallon gasoline can, plastic containers and torn rags. Also seen was a small pistol. All five persons in the vehicle were arrested and charged on a local level with carrying concealed weapons and possession of destructive devices.

On January 17, 1973, following a preliminary hearing for the five individuals arrested, officials of the Community Action Agency telephonically called police complaining that Indians were causing trouble at the agency office. Police responded, however, the individuals refused to leave and sheriff's deputies and police proceeded to remove these individuals from the office. According to officials, resistance ensued and several arrests were made.

The above information at Scottsbluff, Nebraska, was furnished by Police Chief JAMES A. TEAL, JR., Scottsbluff, Nebraska.

The Albuquerque Division of the FBI advised that on January 28, 1973, six male Indians took over the Public Health Service Indian Hospital, Gallup, New Mexico. The Indians were armed with rifles and claimed to have explosives and threatened to demolish the hospital. Subjects made demands of the hospital administration concerning medical care for the Indians and stated that they were occupying the hospital on behalf of AIM. After discussions with an FBI Agent and the District Attorney, all six individuals surrendered and were taken into custody. Indictments were returned by the County Grand Jury on February 2, 1973, on nine counts, including aggravated assault, criminal trespass and unlawful use of public property.

On January 24, 1973, JOHN MANKE, Sheriff, Fall River County Hot Springs, South Dakota, advised that DENNIS BANKS and RON PETITE appeared at his office inquiring concerning the stabbing of WESLEY BAD HEART BULL on January 21, 1973. BANKS complained that there was not enough police protection for Indians.

On January 29, 1973, BANKS appeared on Rapid City television angrily accusing the States of Nebraska and South Dakota of being racist. He established February 6, 1973, as a "National Day of Indian Rights" and called for all tribal Indians to convene at Custer, South Dakota, for what he described to be "their finest hour."

On February 1, 1973, the "Omaha World Herald," an Omaha, Nebraska, daily newspaper, reported that RUSSELL MEANS spoke to a group of 50 Indians at a meeting Wednesday night, January 31, 1973, at which time he called for Indians to join an AIM protest caravan to Custer, South Dakota, where he expected 1,000 Indians to gather in front of the Custer Court House, Tuesday, February 6, 1973, to protest the charge of manslaughter against a white man accused of fatally stabbing an Indian.

On January 5, 1973, the "Rapid City Journal," a daily Rapid City, South Dakota, newspaper quoted RON PETITE, former Executive Director of the Sioux Indian Emergency Care and Rehabilitation Center, Rapid City, as saying he requested that AIM come to Rapid City to "chain up the doors of big business enterprises, Federal agencies and state and local community service agencies."

The Minneapolis Division of the FBI advised as follows:

On February 6, 1973, a caravan of 27 cars loaded with Indians left Rapid City, South Dakota, and proceeded to Custer, South Dakota. DENNIS BANKS, RUSSELL MEANS and two other Indians entered the Court House and met with the state's attorneys for Custer and Fall River County. After about seven minutes of argument, MEANS left the room and was reported by local officers to call on Indians to break into the Court House and burn it. They surged into the Court House and fought with local police officers. When fighting started, BANKS produced a club and beat on desks and furniture. Two Custer sheriff's patrol cars parked in front of the Court House were destroyed by the crowd. Members of the crowd poured gasoline onto the hallway of the Court House and ignited a fire causing extensive damage to the lower floor. A fire was set at an unoccupied Chamber of Commerce building across the street, which burned to the ground. Local and state police in Custer arrested 24 individuals, including RUSSELL MEANS, on charges of arson, riot and assault.

On February 27, 1973, approximately 200 American Indian Movement (AIM) members and supporters assembled in Calico Hall, Calico, South Dakota, and were addressed by RUSSELL MEANS and CLYDE BELLECOURT. Approximately 50 activists armed with rifles, shotguns, pistols, clubs, and knives were present.

Following this meeting, a motor caravan was formed and traveled from Calico, South Dakota, to Wounded Knee, South Dakota, both towns being located on the Pine Ridge Indian Reservation.

During the evening of February 27, 1973, under the primary leadership of RUSSELL MEANS, DENNIS BANKS, CARTER CAMP, CLYDE BELLECOURT, PEDRO BISSONETTE, STANLEY HOLDER, and LEONARD CROW DOG, approximately 200 Indians (160 adult males and 40 women and children) seized a church and the Wounded Knee Trading Post in the town of Wounded Knee. During the evening and on the following day, 11 white hostages, including a Roman Catholic priest, were also seized. It is noted that these hostages were later permitted the option of leaving Wounded Knee if they so desired. The Indians burned bridges on the two roads entering the town, established roadblocks, built bunkers, and assigned armed guards to various positions and patrols to secure and maintain their possession of the town as well as to impede Federal officers in the performance of their official duties.

In the ensuing days, the Indians and Federal law enforcement officers engaged in a number of fire fights and individual actions in which one Federal Bureau of Investigation (FBI) Special Agent and one United States Marshal were wounded and one FBI Special Agent assaulted. In addition, several police and fire vehicles were damaged by rifle fire.

In furtherance of the occupation of Wounded Knee, homes and house trailers were seized by the Indians and used for shelter and feeding and for the organization of security patrols. The Wounded Knee Trading Post and adjacent museum were looted, as were private homes in the area. The

Trading Post was ultimately destroyed by fire and several homes, trucks, and automobiles belonging to local residents were likewise set afire and destroyed by the Indians.

Negotiations between the Indians and representatives of the United States Government were instituted shortly after the initial takeover of Wounded Knee. On May 8, 1973, after 70 days, a disarmament agreement was implemented and the occupation of Wounded Knee came to an end.

IV. INFORMATION RELATING TO PRELIMINARY PROSECUTIVE ACTION

On March 20, 1973, a 9 count indictment was filed in the District of South Dakota, Western Division, (CR 73-5035), charging RUSSELL MEANS with violations involving Burglary, Larceny, Impeding Federal Officers During Civil Disorder, Conspiracy, Assaulting Federal Officer, and Possession of Unregistered Firearms. On April 10, 1973, a supplemental indictment was filed in the District of South Dakota, Western Division, (CR 73-5063), charging MEANS with 2 additional counts of Assaulting a Federal Officer.

Bench warrants issued in reference to the above charges were subsequently executed and bond recommended was set at \$50,000.00 (surety), returnable Sioux Falls, South Dakota.

The Grand Jury Charges:

COUNT I

On or about February 27, 1973, at Wounded Knee, in Indian country, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States, in the District of South Dakota, Russell Means, an Indian, did wilfully, knowingly and unlawfully break and enter into the Wounded Knee Trading Post, a building where property was kept, with intent to commit a larceny, in violation of 18 U.S.C. §1153 and S.D.C.L. §22-32-9.

COUNT II

On or about February 27, 1973, at Wounded Knee, in Indian country, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States, in the District of South Dakota, Russell Means, an Indian, did wilfully, knowingly and unlawfully take and carry away, with intent to steal and purloin firearms, ammunition, food and other items, the personal property of another, to-wit: the Wounded Knee Trading Post, of a value of more than \$100, in violation of 18 U.S.C. §1153 and §661.

COUNT III

On or about the 8th day of March, 1973, near Wounded Knee, in the District of South Dakota, Russell Means, wilfully, knowingly and unlawfully and by means and use of a dangerous weapon, that is a gun, did forcibly assault Joanne Pierce, a special agent of the Federal Bureau of Investigation of the Department of Justice, while the said officer was engaged in the performance of her official duties, in violation of 18 U.S.C. §111 and §1114.

COUNT IV

On or about the 28th day of February, 1973, at Wounded Knee in the District of South Dakota, Russell Means, did wilfully knowingly and unlawfully commit an act to obstruct, impede and interfere with U. S. Marshals and agents of the Federal Bureau of Investigation who were then engaged in the lawful performance of their official duties incident to and during the commission of a civil disorder at Wounded Knee, South Dakota, which civil disorder obstructed, delayed and adversely affected commerce and the conduct of a federally protected function, in that said defendant did prepare and locate trenches and bunkers at Wounded Knee, which were manned by persons armed with guns, in violation of 18 U.S.C. §231(a) (3)

COUNT V

On or about the 28th day of February, 1973, in the District of South Dakota, Russell Means, did wilfully, knowingly and unlawfully commit an act to obstruct, impede and interfere with U. S. Marshals and agents of the Federal Bureau of Investigation, who were then engaged in the lawful performance of their official duties incident to and during the commission of a civil disorder at Wounded Knee, South Dakota, which civil disorder obstructed, delayed and adversely affected commerce and the conduct of a federally protected function, in that said defendant did block a road leading into the community of Wounded Knee by placing vehicles across said road to form a roadblock, and did station persons armed with guns at said roadblocks, in violation of 18 U.S.C. §231(a)(3).

COUNT VI

On or about the 28th day of February, 1973, at Wounded Knee, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States, in the District of South Dakota, Russell Means, an Indian, did wilfully, knowingly, unlawfully and maliciously, set fire to and burn motor vehicles belonging to the Wounded Knee Trading Post, in violation of 18 U.S.C. §1153 and 18 U.S.C. §81.

COUNT VII

That on or about the 6th day of March, 1973, in the District of South Dakota, Russell Means did wilfully, knowingly and unlawfully possess firearms, that is destructive devices commonly known as Molotov Cocktails, which devices had not been registered under the National Firearms Registration and Transfer Record as required by Chapter 53, Title 26, United States Code; in violation of §5861(d) and §5871, United States Code.

COUNT VIII

On or about the 28th day of February, 1973, in Indian country, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States in the District of South Dakota, Russell Means, an Indian, did wilfully, knowingly and unlawfully take and carry away with intent to steal and purloin, a 1970 Dodge automobile, South Dakota license No. 65-1886, the property of another, to-wit: Cleve Gildersleeve, of a value of more than \$100, in violation of 18 U.S.C. §1153 and §661.

COUNT IX

1. Beginning on or about February 28, 1973, and continuing up to the date of the return of this indictment in the State and District of South Dakota and elsewhere, Russell Means an Indian, and defendant herein, wilfully, knowingly and unlawfully did combine, conspire, confederate and agree with Dennis Banks, Clyde Bellecourt, Pedro Bissonette and Carter Camp, Indians, being coconspirators not named as defendants herein, and with other persons unknown to the Grand Jury, to commit offenses against the United States, that is:

a. To break and enter themselves, and in the company of other Indians, the Wounded Knee Trading Post, a building where property is kept, with intent to steal and purloin the property of another, that is property owned by the Wounded Knee Trading Post located within the Pine Ridge Indian Reservation within Indian country; in violation of 18 U.S.C. §1153 and S.D.C.L. §22-32-9;

b. To take and carry away themselves, and in the company of other Indians, with intent to steal and purloin, guns, ammunition, foodstuffs and other things to the Grand Jury unknown, personal property of another of a value in excess of \$100, that is to say, property owned by the Wounded Knee Trading Post located within the Pine Ridge Indian Reservation and within Indian country, in violation of 18 U.S.C. §1153 and §661.

c. To take and carry away themselves, and in the company of other Indians, with intent to steal and purloin, automobiles and personal property of another of a value in excess of \$100, that is to say, property owned by Indian and non-Indian residents of Wounded Knee located within the Pine Ridge Indian Reservation and within Indian country; in violation of 18 U.S.C. §1153.

d. To commit and attempt to commit acts to obstruct, impede and interfere with firemen, United States Marshals, Special Agents of the Federal Bureau of Investigation and Bureau of Indian Affairs policemen then lawfully engaged in the performance of their official duties incident to and during the commission of a civil disorder at Wounded Knee, South Dakota, which civil disorder delayed, obstructed and adversely affected the conduct and performance of federally protected functions and the movement of articles and commodities in commerce; in violation of 18 U.S.C. §231(a)(3);

e. To wilfully and by means and use of dangerous weapons, that is rifles, shotguns and handguns, forcibly assault, resist, oppose, intimidate and interfere with agents of the Federal Bureau of Investigation and United States Marshals engaged in the lawful performance of their official duties; in violation of 18 U.S.C. §111 and §1114;

2. It was a part of the conspiracy that the defendant and his coconspirators, in order to attract public attention to claimed grievances and demands and to seek to obtain concessions from the United States and officers and employees thereof with respect to said grievances and demands, would forcibly take possession of and occupy the Wounded Knee Trading Post in Wounded Knee, South Dakota.

3. It was a further part of said conspiracy that the defendant and his coconspirators would unlawfully obtain and cause to be obtained, firearms, ammunition, foodstuffs, automobiles and other things to the Grand Jury unknown, for use in forcibly preventing agents of the Federal Bureau of Investigation, United States Marshals and other law enforcement officers from freely entering the town of Wounded Knee to carry out their official law enforcement duties and functions.

4. It was a part of said conspiracy that the defendant and his coconspirators would seize and cause to be seized the Sacred Heart Catholic Church in Wounded Knee, South Dakota, to be used for eating and sleeping during the occupation of Wounded Knee, South Dakota.

5. It was a further part of the said conspiracy that the defendant and his coconspirators would seize and cause to be seized homes and house-trailers in the town of Wounded Knee to be used for shelter and eating and for organizing security patrols during the occupation of Wounded Knee, South Dakota.

6. It was a further part of said conspiracy that the defendant and his coconspirators would select and cause to be selected, persons designated as "guards" and did cause such persons to patrol the area surrounding Wounded Knee, South Dakota, for the purpose of resisting and obstructing law enforcement

officers from gaining access to Wounded Knee, South Dakota.

7. It was a further part of said conspiracy that the defendant and his coconspirators did place and cause to be placed, automobiles on the roads leading to and from Wounded Knee, South Dakota, for the purpose of obstructing and impeding law enforcement officers in the performance of their official duties.

8. It was a further part of said conspiracy that the defendant and his coconspirators did dig and cause to be dug trenches and bunkers which could be used for the purpose of directing gun fire at law enforcement officers lawfully engaged in the performance of their official duties.

OVERT ACTS

At the times hereinafter, the defendant and/or his coconspirators committed the following overt acts in furtherance of the conspiracy and to effect the objects thereof:

1. On or about the 27th day of February, 1973, in the State and District of South Dakota, Russell Means drove in a caravan of motor vehicles from Calico, South Dakota, to Wounded Knee, South Dakota.

2. On or about the 27th day of February, 1973, in the State and District of South Dakota, Pedro Bissonette drove in a caravan of motor vehicles from Calico, South Dakota, to Wounded Knee, South Dakota.

3. On or about the 27th day of February, 1973; in the State and District of South Dakota, Russell Means and Pedro Bissonette, and others whose names to the Grand Jury are unknown, prepared a list of demands of the coconspirators to be delivered to officers and employees of the United States.

4. On or about the 28th day of February, 1973, in the State and District of South Dakota, Pedro Bissonette met with Joseph H. Trimbach, Special Agent in Charge, Federal Bureau of Investigation.

5. On or about the 28th day of February, 1973, in the State and District of South Dakota, Carter Camp met with Joseph H. Trimbach, Special Agent in Charge, Federal Bureau of Investigation.

6. On or about the 28th day of February, 1973, in the State and District of South Dakota, Russell Means delivered to Joseph H. Trimbach, Special Agent in Charge, Federal Bureau of Investigation, a list of persons being held by defendant and his coconspirators.

Television News Films

1. On April 27, 1973, SAMUEL ANTAR, Director, Legal and Business Affairs, ABC News, 7 West 66th Street, New York City, New York, furnished two canisters of 16 mm film.

The information on the 2" video tape was transferred to 16 mm film by BYRON Motion Picture Laboratory, 65 K Street, N.W., Washington, D.C. Special Agent [redacted] Washington Field Office, Washington, D.C., compared the 2" video tape with the 16 mm copy, and he determined that the 16mm film was an authentic reproduction of the video tape in regards to the information pertaining to the events at Wounded Knee, South Dakota.

A review of the 16 mm films by Special Agents of the FBI revealed several sequences depicting the presence of AIM leaders RUSSELL MEANS, CARTER CAMP, LEONARD CROW DOG, CLYDE BELLECOURT, STANLEY HOLDER, and DENNIS BANKS at Wounded Knee, South Dakota. The films have been viewed by United States Attorney WILLIAM F. CLAYTON, and the films have been made available to him for trial purposes.

Photographs

On April 30, 1973, [redacted] UPI, 220 East 42nd Street, New York City, New York, furnished the FBI with 148 UPI photographs pertaining to the AIM occupation

of Wounded Knee, South Dakota, from February 27, 1973, to May 8, 1973. Several of these photographs depict AIM leaders RUSSELL MEANS, DENNIS BANKS, LEONARD CROW DOG, STANLEY HOLDER, CLYDE BELLECOURT, and CARTER CAMP.

United States Attorney WILLIAM F. CLAYTON, Sioux Falls, South Dakota, has reviewed these photographs and at his request, three copies each of 72 of the photographs are being furnished to him for trial purposes.

In addition to the UPI photographs, 306 photographs taken by Special Agents of the FBI during and immediately after the AIM occupation of Wounded Knee were viewed by United States Attorney WILLIAM F. CLAYTON. These photographs depict: (1) views of Wounded Knee taken from the Government roadblocks; (2) the Government roadblocks; (3) damage to Government vehicles as a result of having been fired upon; (4) the bunkers constructed inside Wounded Knee during the AIM occupation; (5) items recovered which had been taken from the Trading Post in Wounded Knee during the AIM occupation; (6) ammunition and fire bombs abandoned inside Wounded Knee after the AIM occupation ended, and (7) the destruction of property inside Wounded Knee during the AIM occupation.

At the request of United States Attorney WILLIAM F. CLAYTON, three copies each of 176 of the above-described photographs are being furnished to him for trial purposes.

Newspaper Articles Regarding AIM Events Prior to Wounded Knee

A review of publications of the "Rapid City Journal," Rapid City, South Dakota, was made regarding items pertaining to local and near-by events pre-dating the Wounded Knee takeover. Pertinent articles are summarized below regardless of the fact that most were not written under by-lines.

Article entitled "AIM Asked to 'Put Freeze on City' For 'Mistreatment of Indian Veterans'," appears on page three of the January 5, 1973, issue. Substance: Article states RON PETITE, Executive Director of the Sioux Indian Emergency Care and Rehabilitation Center in Rapid City, has contacted DENNIS J. BANKS, National Field Director of AIM, and asked him to "put a freeze on the whole town of Rapid City". Article lists business, Federal, State, and local agencies as targets of the freeze because of their mistreatment of Indians, especially veterans.

Article entitled "Means Will Seek Oglala Presidency," appears on page six of the January 9, 1973, issue. Substance: The national coordinator of the Trail of Broken Treaties, RUSSELL MEANS, stated he will be a candidate for the president of the Oglala Sioux Tribe in November's primary election. If elected, he will propose to abolish the office of tribal president and current tribal Government organizations. He will ask Oglala people to form Oglala Constitution and an Oglala form of Government.

Article entitled "Meet Set Friday to Re-activate Big Foot Claims," appears on page two of the January 10, 1973, issue. Substance: An organizational meeting for the relatives and descendants of Indians involved in the 1890 Wounded Knee Massacre will be held Friday, announced by JOHNSON HOLY ROCK, former Sioux president. Purpose of meeting is to reactivate Big-Foot Claims Council, incorporated in 1948, to prosecute claims against U.S. Government for injuries, death and property loss as result of Wounded Knee Massacre.

Article entitled "AIM Charges Follow Police Charges," appears on page one of the January 15, 1973, issue. Substance: AIM field director, RUSSELL MEANS, said he was beaten by Scottsbluff Police Officer after he was jailed Saturday night. MEANS, along with EDGAR BEAR RUNNER, was jailed after police answered a second call to quiet down a private party at the Park Motel in Scottsbluff. MEANS charged with intoxication, disorderly conduct, resisting arrest, and carrying a concealed weapon. DENNIS J. BANKS, national field officer of AIM called all thirty-five chapters of AIM to report to Scottsbluff "prepared to liberate AIM officials."

Article entitled "Another AIM Leader Arrested in Scottsbluff," appears on page two of the January 16, 1973, issue. Substance: The Nebraska Director of AIM, JOHN TWO BIRDS ARBUCKLE, along with LEROY CASADOS, were arrested when police found gasoline and other material for making Molotov cocktails, three automatic weapons, a club, and marijuana in CASADOS' van. Earlier in the evening eighty Indians and some Mexican-Americans marched in Scottsbluff City Hall where KEITH MATZKE, Head of the Scottsbluff AIM Chapter, asked to file a formal complaint of police harassment.

Article entitled "Minority Confrontations Quieter in Scottsbluff," appears on page two of the January 17, 1973, issue. Substance: Situation quieter after three days of confrontations. Indians hold news conference opened by LEONARD CROW DOG - MEANS says "We took on the Federal Government and we're not scared of the pigs in Scotts Bluff County."

Article entitled "AIM Calling Indians to Custer Rights Day," appears on page two of the January 30, 1973, issue. Substance: AIM National Field Director, DENNIS BANKS, declared Custer as the focal point for a National Day of Indian Rights on February 6, 1973. BANKS designated February 6, 1973, as "a good day to die," and the date coincides with a preliminary hearing on a manslaughter charge in connection with the death of an Indian man from Hot Springs.

Article entitled "Indian Group Claims 'Rampant Discrimination'," appears on page two of the February 2, 1973, issue. Substance: AIM official, DENNIS BANKS, opened meeting of the Rapid City Indian Civil Rights Task Force by comparing Senator GEORGE MC GOVERN with General Custer and invited MC GOVERN to Custer on February 6, 1973, to lead the charge of the old Seventh Calvary and be defeated again. The group listed examples of racial discrimination against Indians in Rapid City.

Article entitled "Indians List Discrimination Complaints," written by HAROLD HIGGINS, Journal Staff Writer, appears on page three of the February 3, 1973, issue. Substance: AIM leader DENNIS BANKS opened meeting of Rapid City Civil Rights Task Force hearings on job and housing discrimination. Other moderators included HERB POWLESS, AIM leader from Milwaukee, and Attorney RAY HABER from the Native American Rights Fund of Denver.

Article entitled "More Testimony Scheduled Sunday on Indian Rights," appears on page two of the February 4, 1973, issue. Substance: DENNIS BANKS and AARON DE SERSA, JR., as primary witnesses claim discrimination against Veterans Administration Hospital and arrests of Indian population.

Article entitled "AIM Leaders Say Caravans Custer Bound," appears on page one of the February 7, 1973, issue. Substance: AIM states 1,500 Indians will be in Custer Thursday or Friday. It said caravans are coming from Oklahoma, Washington, Arizona, Colorado, and Nebraska.

Article entitled "Indians Face Variety of Charges," appears on page one of the February 7, 1973, issue. Substance: Twenty-two Indians arrested at Custer Tuesday will be charged with "inciting to riot, obstructing justice, assaulting a police officer, destroying public property and arson.

Article entitled "Banks Issues 'Call to Arms' Guard in Custer," appears on page one of the February 9, 1973, issue. Substance: AIM leader DENNIS BANKS stated "As long as the militia is allowed to go on the rampage in Custer and threaten every Indian's life with arms, then AIM will not consider anyone in Custer innocent. Indians throughout a 10 state area are being called to arms to join in the protest," BANKS said in a prepared statement.

Article entitled "Violence Flares in City; 16 Hurt, 40 Arrested," appears on page one of the February 10, 1973, issue. Substance: Several people hurt and forty arrested after a fracas involving Indians and non-Indians erupted in four Main Street bars. AIM leaders DENNIS BANKS and RUSSELL MEANS say outbreak not planned by them.

Article entitled "AIM Leader Speaks at Church," appears on page three of the February 12, 1973, issue. RUSSELL MEANS, AIM leader, accompanied by twenty-five Indians, spoke during an open forum between the Sunday morning services at First United Methodist Church; spoke about AIM organization in 1968, and outlined purposes of AIM.

Article entitled "AIM Angry With Council; Midwest Conference Continues Here," appears on page one of the February 13, 1973, issue. Substance: AIM leaders lifted curfew and "cease-fire" in the Black Hills Monday because of "city council attempts to intimidate AIM" - CARTER CAMP, Oklahoma AIM leader, and approximately 200 AIM members in Rapid City for convention.

Article entitled "Ministerial Group, AIM Leaders Study Problems in City," appears on page three of the February 15, 1973, issue. Substance: Thirty members of the Rapid City Ministerial Association met with AIM leaders including CLYDE and VERNON BELLECOURT. AIM leaders urged the clergy to take a more active leadership and explain Indians problem to white men.

Article entitled "Central Students Hear Indian Movement Goals," appears on page three of the February 16, 1973, issue. Substance: Approximately 1,000 students at Rapid City Central High School attended a speech by AIM leader DENNIS BANKS Thursday morning. BANKS spoke for approximately an hour and followed with a fifteen minute question and answer period. Some students walked out of meeting and shouting match started after a student asked if Indians demanded preferential treatment.

Article entitled "Pine Ridge Conspiracy Charge Made," appears on page one of the February 17, 1973, issue. Substance: AIM National Director, VERNON BELLECOURT, claimed acts of conspiracy against U.S. Government, Interior Department, BIA, and RICHARD WILSON acting against AIM.

Article entitled "Roubideaux Accuses Lytle of Bad Faith, Bigotry," appears on page one of the February 19, 1973, issue. Substance: RAMON A. ROUBIDEAUX, Rapid City Attorney for AIM, criticized LARRY LYTLE, President of the Rapid City Common Council, in a stalemate for what he termed bad faith and insensitivity to racial problems in the city.

Article entitled "Group Evicted From Motel, Police Confiscate Weapons," appears on page three of the February 21, 1973, issue. Substance: The Manager of the Imperial 400 Motel asked City Council for help to evict a group of AIM members who had run up bills totaling nearly \$2,500. Police evicted the AIM members and confiscated several clubs, knives, two guns, and a crossbow. No arrests were made.

Article entitled "AIM Caravan Said Going to Pine Ridge," appears on page one of the February 25, 1973, issue. Substance: AIM leader VERNON BELLECOURT said an AIM caravan will leave Rapid City Sunday to travel to the Pine Ridge Reservation "in response to requests from the people of Pine Ridge." BELLECOURT said, "I understand there is an armed camp awaiting us, but AIM has always responded to a request from the Indian people and we are going."

Article entitled "Indians Control, Hold 9 Hostages at Wounded Knee," appears on page one of the February 28, 1973, issue. Substance: Nearly 200 Indians were in control of Wounded Knee. CARTER CAMP, AIM spokesman, said hostages had not been hurt and were in no danger "unless the police come in here and try to annihilate us." Demands include an investigation of the dealings of BIA and the Department of Interior with the Oglala Sioux.

Article entitled "Current Reservation Trouble Has a Long History," appears on page one of the February 28, 1973, issue. Substance: Article outlines past history of reservation trouble which began to crystalize November 2, 1973, and summarizes major disputes.

Article entitled "Mayor Vows Action on Racial Complaints," written by HAROLD HIGGINS, Journal Staff writer, appears on page one of the February 8, 1973, issue. Substance: AIM leader DENNIS BANKS makes statement "We're going to burn down those racist towns," referring to action to be taken by AIM against towns discriminating against Indians - after incident at Custer, South Dakota, on February 6, 1973.

Article entitled "Rights Resolution Passed," written by BOB FELL, Journal Staff writer, appears on pages one and two of the February 21, 1973, issue. Substance: DENNIS BANKS makes statement "The bells of peace will not ring tomorrow. We'll see you in the streets." Statement made to Rapid City Common Council at meeting between Council members and AIM members on night of February 20, 1973.

Article entitled "Observer Describes Takeover," written by WALTER FISK of Washington, D.C., Bureau Chief of U.S. News Service, appears on pages one and two of the March 1, 1973, issue. Substance: Author describes takeover at Wounded Knee - makes specific reference to RUSSELL MEANS stating "We've got the whole Wounded Knee valley here." "We have secured it and we're definitely going to hold it until death do us part." MEANS continues by describing AIM's demands.

Article entitled "Fire Bombing Tempers Optimism at Wounded Knee," written by LYN GLADSTONE, West River Editor of Rapid City Journal, appears on pages one and two of the March 2, 1973, issue. Substance: Article states that DON POLOVICH, Journal Photographer, was at meeting with Senators JAMES ABOUREZK and GEORGE MC GOVERN at the RIEGERT's in Wounded Knee. He reported seeing many weapons and some of the dugouts and trenches which had been dug around Sacred Heart Church.

Article entitled "Wounded Knee Situation Tense," written by F. RICHARD CICCONE, appears on pages one and two of the March 3, 1973, issue. Substance: DENNIS BANKS said Indian leaders did not want to face kidnapping charges. "I can see two or three years in jail, but I can't see 17 years," said BANKS in reference to the minimum sentence for kidnapping in South Dakota.

Article entitled "Lawyers Meet with Indians," written by F. RICHARD CICCONE, Associated Press (AP), appears on pages one and two of the March 4, 1973, issue. Substance: Author states AIM leader, RUSSELL MEANS, urged the Indians at Wounded Knee to keep their discipline and also warned his followers not to waste their shots.

Article entitled "New Peace Talks Set with Indians," written by F. RICHARD CICCONE, AP, appears on pages one and two of the March 5, 1973, issue. Substance: Article makes reference to CARTER CAMP, DENNIS BANKS, and RUSSELL MEANS burning Government proposal to end armed standoff. (Picture showing BANKS and MEANS with MEANS holding burning paper.)

Article entitled "Inside Wounded Knee Village - Armed Clash Never Far From Indians Minds," written by JAMES WILSON, AP writer, appears on page three of March 5, 1973, issue. Substance: Article describes weapons in possession of Indians, firefights, mentions RUSSELL MEANS, shooting at Air National Guard Planes overhead, mentions shooting a cow by Indians and their attempting to skin it.

Article entitled "Village Evacuation Underway," written by F. RICHARD CICCONE, AP, appears on page one of March 8, 1973, issue. Substance: Remaining hostages were evacuating Wounded Knee - CARTER CAMP, spokesman for AIM states reinforcements were on the way.

Article entitled "Sioux Donned War Paint - Wounded Knee Residents Moved Before Deadline," written by LYN GLADSTONE, West River Editor, appears on page one of March 9, 1973, issue. Substance: Article relates how author and Rapid City Journal Photographer, DON POLOVICH, made exit from Wounded Knee. Relates about Indians receiving war paint. CARTER CAMP said members of REIGERT and GILDERSLEEVE families who owned Wounded Knee Trading Post had given AIM option to buy for \$2.5 million. CARTER CAMP explains AIM's plans for future strategy and tells of people planning to come to Wounded Knee such as Reverend PHILLIP BERRIGAN.

Article entitled "Gun Battle Breaks Out - Indians Seek Removal of Lawmen at Wounded Knee," written by F. RICHARD CICCONE, AP, appears on pages one and two of the March 10, 1973, issue. Substance: Article tells about fire fight between Indians and lawmen. Quotes DENNIS BANKS telling why the Indians were rejecting the Government withdrawal time.

Article entitled "Indian Forces Determined Despite Food Shortage and Coughs," written by JOHN LINQUIST, AP writer, appears on page two of the March 10, 1973, issue. Describes conditions within Wounded Knee, tells about food shortages, quotes DENNIS BANKS as saying "We have to avenge those two brothers who were shot. We have to avenge them before we leave."

Article entitled "Indians Claim Victory Over Government," written by F. RICHARD CICCONE, AP, appears on page one of the March 11, 1973, issue. Substance: Article quotes DENNIS BANKS and RUSSELL MEANS' reactions to Government removing roadblocks.

Article entitled "Wounded Knee Circumstances Jury Topic," written by F. RICHARD CICCONE, AP, appears on page one of the March 12, 1973, issue. Substance: Article relates FBI Agent FITZGERALD shot. DENNIS BANKS quoted "The FBI is trying to provoke the situation." RUSSELL MEANS proclaims Wounded Knee was now the Oglala Sioux Nation, a Sovereign State. MEANS states "Any spies enter the village, they will be treated like spies everywhere and will face a firing squad...If any foreign official of any foreign country, specifically the United States, tries to enter the village, it will be treated as an act of war and treated accordingly." Indians hold Postal Inspectors. DENNIS BANKS states he is not obstructing justice.

Article entitled "Federal Authorities Re-establish Barriers Around Wounded Knee," written by F. RICHARD CICCONE, AP, appears on page one of the March 13, 1973, issue. Substance: RUSSELL MEANS said in the 1868 Treaty, the Sioux were promised all the land west of the Missouri River in Dakota Territory which now includes North Dakota, South Dakota, Wyoming, Nebraska, and Montana - "Now we want it," MEANS said.

Article entitled "Occupation Force Talks of Plans for 'Nation'," written by JAMES F. WILSON, AP writer, appears on page two of the March 13, 1973, issue. Substance: RUSSELL MEANS states as far as he is concerned, their nation is already at war with the U.S.

Article entitled "The Anatomy of Takeover at Wounded Knee," written by F. RICHARD CICCONE, AP, appears on page three of the March 18, 1973, issue. Substance: Article summarizes events at Wounded Knee, quotes DENNIS BANKS as saying "We counted on the Press getting in here to get national opinion on our side."

Substance: RUSSELL MEANS said at news conference 500 Sioux Indians to enter village Sunday to attend religious services. They will be armed with hunting equipment and will carry food supplies. If attempts are made to restrict their access, those efforts will be met with force.

Article entitled "Court Order Stops Cutting Off Wounded Knee Supplies," written by TERRY WOOSTER, AP, appears on pages one and two of the March 26, 1973, issue. Substance: Article tells about Indians obtaining court order to allow food supplies for Indians at Wounded Knee. RUSSELL MEANS says a possible breakthrough in stalemate might be expected Monday.

Substance: Siege reported ended - RUSSELL MEANS under arrest heads for Washington to meet with Federal officials - MEANS describes the agreement as a small victory for the Indians.

Article entitled "Means Unhappy With Bail Terms, But Sees Victory," written by LYN GLADSTONE and JACK WEAVER, Journal Staff writers, appears on page one of the April 6, 1973, issue. Substance: MEANS states his two and one-half hour closed hearing regarding his bail bond "shows that the white man still refuses to listen and the white people of Western South Dakota will have to deal with me, with my relatives and with all Indian people."

Article entitled "Indians Still Keeping Arms at Village," written by TERRY DEVINE, AP, appears on page one of the April 9, 1973, issue. Substance: DENNIS BANKS says the occupation force won't give up its weapons until the talks are completed.

Article entitled "'Vision' Suggests New Proposal," written by TERRY DEVINE, AP, appears on page one of the April 11, 1973, issue. Substance: AIM gives new proposal to end Wounded Knee occupation based on vision of medicine man, LEONARD CROW DOG, to stack weapons.

Article entitled "Bellecourt Submits To Arrest: Bond Arraignment Set," written by LYN GLADSTONE, Journal West River Editor, appears on page one of the April 13, 1973, issue. Substance: CLYDE H. BELLECOURT came out of Wounded Knee to submit to arrest. BELLECOURT said he had been in Wounded Knee since the occupation started and that "I don't think it will be settled soon."

Article entitled "Nurse's Concern For Insurgents Unique in Reservation Area," written by JAMES WILSON, AP, appears on page two of the April 23, 1973, issue. Substance: Article describes interview with LYNAANE JACOB of Oakland, California, who acted as nurse for Indians in Wounded Knee - tells about living conditions in Wounded Knee (makes no mention about AIM leaders).

Article entitled "Government - AIM Negotiations Resume," written by TERRY DEVINE, appears on page one of the April 29, 1973, issue. Substance: DENNIS BANKS and LEONARD CROW DOG met for two hours with Interior Department Solicitor KENT FRIZZELL (no quotes from above-mentioned AIM leaders).

Article entitled "Signers of Agreement Optimistic," written by TERRY WOOSTER, AP, appears on page one of the May 7, 1973, issue. Substance: Article tells about first phase of a disarmament agreement. Refers to a letter written by DENNIS BANKS to AIM lawyer, RAMON ROUBIDEAUX, which reportedly stated in part, "It must be understood that AIM was called on to aid the Oglalas in their struggle against repressive Government forces."

Unless otherwise stated, all sources mentioned in this communication have furnished reliable information in the past.

Source advised on November 9, 1973, that captioned individual, American Indian Movement leader, arrived in Los Angeles, California, November 9, 1973, and taped a television interview for the television show entitled, "Impacto" to be aired November 24, 1973.

The American Indian Movement (AIM) was founded in Minnesota in 1968, dedicated to improving conditions for the American Indian. AIM recently led and participated in confrontations with local authorities in Scottsbluff, Nebraska, and the Rapid City-Custer area of South Dakota. AIM led the takeover and occupation of Wounded Knee, South Dakota, in February-May, 1973.

The following is a transcript of the television show, "Impacto" in which captioned individual and Randy Edmonds, Director of the Indian Center, Inc., were the main guests:

ANNOUNCER: That storm brings destruction and death but it also brings rain to grow the grass for new life, for there is good in everything. The center of the storm, called Wounded Knee, is RUSSELL MEANS. RUSSELL MEANS, welcome to "Impacto". VERNON BELLECOURT, AIM leader, said, "If AIM fails to get Federal action to improve life for American Indians, AIM will become the uninvited guest to America's 200th birthday celebration and blow out the candles".

RANDY EDMONDS, Director of the Indian Center, welcome to "Impacto".

RANDY EDMONDS: Thank you.

ANNOUNCER: Mr. MEANS, what is, what is the significance of Wounded Knee?

RUSSELL MEANS: The significance of Wounded Knee was before, during, and after our treaty rights, you know, the uh the United States Government and even the press foul--fouled to that whole rap that it was Indian fighting Indian. That's not the case. That's incidental to our treaty rights. The 1868 Sioux Treaty is what Wounded Knee was all about and is still today; because, of course, I'm going to court over it,

and uh, so is DENNIS BANKS and and the other four so-called leaders of Wounded Knee and over 300 other defendants are going to court to prove that our treaty rights are more important than our own lives.

ANNOUNCER: RUSSELL, one of the things that surprises a lot of us in the movement, and in the Chicano movement, and in the ethnic movement, is that most minority groups in America, today, are on a civil disobedience uh approach to--to problems and to their resolution, but AIM is going for confrontations....

RUSSELL MEANS: I don't, I don't go for that...crap about civil disobedience because all AIM is trying to do is force the United States of America to live up to its own laws-- that's all--it's that simple. They made treaties with us, either--they either live up to those treaties or we'll die fighting for those treaty rights. And that's all AIM says. United States of America, you live up to your uh....your own laws.

ANNOUNCER: But RUSSELL, isn't it, sort of, unrealistic to say that the Oglala Nation is an independent nation within America?

RUSSELL MEANS: Why? After we gave you the Western Hemisphere...

but not you, my friend, (announcer laughs) but uh, you know, White America...

ANNOUNCER: Uh huh

RUSSELL MEANS: We gave them the Western Hemisphere and and they still won't leave us alone. They still have genocidal policies to get rid of American Indian people, through missionary schools, through BIA boarding schools, through-- the whole spectrum of Indian Affairs is a genocidal policy. Now our water rights, our mineral rights--right now, the United States of America is concerted, a concerted effort to rip off our coal, strip mine our reservations, and build oil pipelines from Alaska, over Indian land, over native land, down into the United--to fuel Los Angeles, and Phoenix, and all those over rip off, smog, pollution areas.

ANNOUNCER: RANDY EDMONDS, you're the director of the LA Indian Center, what's the reaction of the American Indian community in Los Angeles to AIM?

RANDY EDMONDS: Well, I think a lot of the uh people there involved in, probably the thinking of American Indians trying to get response from the Federal Government uh, somewhat, back AIM to the point that in order to get the Federal Government to respond, there has to be a confrontation uh where that

uh the Federal Government rec--will recognize American Indians. I think AIM has come ab--about uh in creating--creating this situation through the Wounded Knee thing but uh a lot of the people that live in Los Angeles area are probably working-class Indians and uh really can't afford, I think at this point--to get involved in these kinds of uh situations, as far as local kinds of things that are going on. Uh we do have a chapter here but uh uh uh their thinking is in in line with the American Indian Movement. . As far as I'm concerned, I I uh I kind uh I guess uh uh concentrate on trying to I guess, knock on the door and say, "Hey, may I come in?"....

ANNOUNCER: And what does AIM do?

RANDY EDMONDS: Uh RUSSELL MEANS, I guess, kind of knocks the door down and then goes on in and knock--and negotiates...

ANNOUNCER: Uh huh

RANDY EDMONDS: Uh...

ANNOUNCER: Well you've been quoted as saying that the difference between your tactics and and AIM is that you still believe on knocking on doors and uh AIM uh knocks doors down. What do you think about that RANDY?

RANDY EDMONDS: RUSS--you're talking to RUSS or...

ANNOUNCER: No, I'm talking to you.

RANDY EDMONDS: Okay. (Announcer laughs). Uh well, I think, you know, that, I've I've lived in urban area for about 20 years now, and I've lived, I guess within a community, uh through the past 20 years and we've developed a lot of organizations, a lot of Indian activities for the American Indians in Los Angeles, and I think if we're going to have live uh in the system that has been created for us, we're going to have to, I guess, play the ballgame as it is played...

ANNOUNCER: Uh huh

RANDY EDMONDS: Uh I have been recently appointed the Human Relations Commissioner for Mayor BRADLEY of Los Angeles and uh, in order to, I guess, work with all ethnic groups, uh we have to, I guess, have this kind of philosophy. Uh, I try to do the kinds of things that I need to do to help our people in the Indian community in Los Angeles, by going through these kinds of uh systems and hopefully uh uh, we'll meet, I guess, as the AIM people and the the kind of conservative people that more or less I represent will meet in the same, I guess, uh road, in the middle of the road, as we go down and looking for the same kinds of response from the Federal Government, or whether it be state, city, or or whatever.

ANNOUNCER: One of the defendants uh--and there are seven major defendants that were indicted at Wounded....

✓RUSSELL MEANS: Six now, PETE, PEDRO BISSONETTE was assassinated by the BIA pigs.

ANNOUNCER: I'm leading to that. PEDRO BISSONETTE was killed on October 17th of this year. And you've charged that he was assassinated by Agents of the Federal Government. Would you care to amplify that charge?

RUSSELL MEANS: You bet, you see, we have a history of assassinations. You know, the United States of America is a master and divider conquerer. They ripped off our whole leadership, during the 1700 and the 1800, and managed to put in their wedge and divide and conquerer. And they did it again with the Black Panthers. They created a climate of uh public relations that got the public standing back, "Wait a minute, who's the Black Panthers?", and when they got that reaction from the public, they--the the Feds went in and assassinated, through local Government, the leadership of the Black Panther Party. And they're doing the same thing to the American Indian Movement now. They are attempting to discredit us in the public eye and at the same time, assassinate our leadership.

ANNOUNCER: Has been there been an investigation into the uh death of uh PEDRO BISSONETTE?

RUSSELL MEANS: Naturally not. If the "Feds" going to kill you, they're not going to investigate it.

ANNOUNCER: Tell me something, RUSSELL, what is life like in the Pine Ridge Indian Reservation? What what kind of aspiration do young people have--on the reservation? What are the conditions?

RUSSELL MEANS: I can not tell to people that do not know what it is like to live under tyranny, absolute tyranny, whereas, as uh as an Indian male, you have expression of your vir--your virality, your--your manhood...

ANNOUNCER: Uh huh

RUSSELL MEANS: You absolutely have no vehicle for expression of your manhood and what--the only escape that is allowed to you is to either sellout and become a fac--two-bit facsimile white man or else, become a uh schizo (ph) bum, commit suicide, whatever.

ANNOUNCER: How many Indians are there in America?

RUSSELL MEANS: According to the 1970 Census, there are approximately uh 825,000 native Americans.

ANNOUNCER: So you compare that to about 15,000,000 Spanish surnamed Americans and what, 25 to 30,000,000 blacks, and you really are America's uh smallest minority then...

RUSSELL MEANS: And the most dep--deprived, the most tyrannized, the most oppressed. If by any scale a measurement, and you know, the facts are there...

ANNOUNCER: mmm hmm

RUSSELL MEANS: in Washington, D.C.

ANNOUNCER: mmm hmm. You said that the policy of the Government, I presume you're referring to the Bureau of Indian Affairs, is that a policy of conquer and divide, and uh the reason I mention that is, Mr. DICK WILSON, he's the travel president of the Oglala Sioux and I understand that you're a candidate uh to replace him....

RUSSELL MEANS: That's providing the Bureau of Indian Affairs will let me run in the presidential election of the Oglala Sioux Tribe...

ANNOUNCER: Why shouldn't they?

RUSSELL MEANS: (Laughs)....

ANNOUNCER: Are you under indictment?

RUSSELL MEANS: At Wounded Knee we have three or five square miles to protect of the independent Oglala nation, Pine Ridge

Reservation entails 250 square miles...

ANNOUNCER: mmm hmm

✓ RUSSELL MEANS: If I become president, I am not going to take the oath of office that pledges my support to the United States of America because I want nothing to do with the United States of America. However, the Bureau of Indian Affairs has the power over Indians on the reservation that are under the Indian Organization Act to say uh, you're a non--a non person--you can't function as a human being, so we take over your affairs. So they they they can say that to me and and and declare me ineligible for uh the election of the travel presidency.

ANNOUNCER: RUSSELL, Wounded Knee, to most Americans, and I would venture to say, 90 percent of Americans would say Wounded Knee was a confrontation in the Spring of 1972, but there was a Wounded Knee in 1890--what happened then?

RUSSELL MEANS: The same thing they tried to happen again in 1973, disarm us and then massacre us. As simple....

ANNOUNCER: Is that what happened in 1890?

RUSSELL MEANS: It's as simple as that. Yes.

ANNOUNCER: What was the story at Wounded Knee in 1890?

RUSSELL MEANS: Well, you want the white man's story, or the

Oglala story, or the Menicoshi (phonetic) story?

ANNOUNCER: We want the Oglala story?

RUSSELL MEANS: Alright, it is the Menicoshi's (ph) that came down from uh North and South Dakota to seek refuge among the Oglala people, and there were Oglala people among the Menicoshi (ph) band that came into Wounded Knee in 1890-- they came down there and surrendered, BIG FOOT, Chief BIG FOOT and his band. It was winter time, December 27, 28th, and they had disarmed the Indian people and then they said one Indian fired a shot, he had hid--hidden a gun, so they massacred 237....

ANNOUNCER: Who did?

RUSSELL MEANS: Men, women, and children. The Seventh Cavalry of the United States of America...the epitome of democracy in this world.

ANNOUNCER: Is the occupation of Wounded Knee in 1973 in the response for the Government similar, analogous to what happened in 1890?

RUSSELL MEANS: You would be surprised because in 1890 the Ghost Dance religion had had wide spread influence among the plain's tribes. We did the Ghost Dance inside Wounded Knee.

ANNOUNCER: mmm hmm

RUSSELL MEANS: Uh the whole spectrum of the events of Wounded Knee was almost parallel with what happened in 1890, only the fact we didn't give up our arms, therefore, we weren't massacred.

ANNOUNCER: But you did give up your arms in 1973, didn't you?

RUSSELL MEANS: After forcing the United States of Gov--United States of America to agree to our demands. However, you know, naturally, it went the same route as all the treaties. They didn't keep up the...

ANNOUNCER: What were those demands that you made in 1973, in the spring of this year?

RUSSELL MEANS: There were six major points, that the Justice Department, or the Injustice Department, as I see it, the Injustice Department stated they would do a comprehensive investigation of criminal activities, and the police brutality on their Indian reservation, on Pine Ridge, where I'm from. Uh another demand was that a complete audit, an honest audit, not only of the tribal government, the "puppet" tribal government of the Bureau of Indian Affairs, but also the Bureau of Indian Affairs would take place...

ANNOUNCER: mmm hmm

RUSSELL MEANS: again and that every civil rights complaint given, and there was over a hundred given, would be investigated by the Injustice Department...none--all of those, over a hundred complaints have been dismissed by the Injustice Department. They have not lived up to one of the stipulations. Another stipulation was that as soon as we evacuated Wounded Knee, the members, the citizens of the independent Oglala nation is that immediately the original residents, those that were outside, would be allowed back in but they delie--delayed that that happening for 24 hours, so the "Feds" could come in there and shoot up the churches and and desecrate Indian homes and even defecate on the floors and charge us with that.

ANNOUNCER: RANDY EDMONDS you have been a resident of Los Angeles for over 25 years, what has been the respond of the traditional Indian community to the uh AIM activity and AIM aims of tactics?

RANDY EDMONDS: I think the uh probably the traditional Indians that uh have probably lived on the reservations, and uh points of origination of concentration of Indians...I do believe that possibly this may be the system that uh is needed to make the Federal Government respond. There are several ways

that you know you make the Federal Government respond or any government, as far as that is concerned and I think probably the old traditional people that have been involved in trying to make the Federal Government respond uh believe that maybe this is the way. Uh you bump your head against the wall so long that uh eventually you take other measures and uh the people that come from uh the reservation areas uh, you know, I think, believe this way. I think the younger generation has uh I guess begin to feel that the ball game is out here and we have to kind of play that ball game.

ANNOUNCER: Can you can you described for the audience uh the Indian community of Los Angeles, where do they live, what do they do?

RANDY EDMONDS: Well the Indian, there is no one Indian community in Los Angeles uh they're fragmented and this was, I guess, deviced by the Bureau of Indian Affairs relocation program and this was brought about by the re-uh the vocational training program that was established by Bureau of Indian Affairs. I guess uh the, probably, the one area that you would consider a community or a concentration of Indians would be in the uh Bell Gardens, uh South Gate, Huntington Park areas....

ANNOUNCER: How many Indians are there?

RANDY EDMONDS: Uh...

ANNOUNCER: In in Los Angeles or the Metropolitan area?

RANDY EDMONDS: Well the Los Angeles county there're about 60,000 Indians. The Bureau of Indian Affairs census says there's about 25,000 Indians, and those are the people that uh they have brought out since 1952 since the relocation program was established.

ANNOUNCER: RUSSELL, Wounded Knee was something that was on the front page for just about three months in every major newspaper in America, and perhaps other, other nations in the world. What was the response of the Chicano community to Wounded Knee?

RUSSELL MEANS: Fantastic. Uh the biggest support we got outside of the Indian people, was from the Chicano community.

ANNOUNCER: What kind of support did you get?

RUSSELL MEANS: Uh physical, supplies, supplies, and uh money, and and in terms of demonstrations in their own cities--it was fantastic.

ANNOUNCER: Were there any Chicanos uh at Wounded Knee?

RUSSELL MEANS: Over uh 100 Chicano people passed through Wounded Knee. There was a hardcore of about 17 that stayed

throughout...Uh the seize at Wounded Knee. And uh when we, when we uh issued citizenship cards to the independent Oglala nation, the uh the Chicanos and the Indian people were issued the same type of citizenship card...

ANNOUNCER: As members of the Oglala nation?

RUSSELL MEANS: As members of the Oglala nation.

ANNOUNCER: I understand that you even went as far as to as to stamp passports of people coming to uh....

RUSSELL MEANS: Yes we uh uh stamped passports of some of the Brittish Press, the uh West German Press, and uh the uh French, Italian, Scandinavian countries, their press that came into Wounded Knee, we stamped their passports, ION, Independent Oglala Nation.

ANNOUNCER: Your under indictment, Federal indictment, and if you're convicted you could serve up to 200 years in prison...

RUSSELL MEANS: 180...

ANNOUNCER: 180 years. Will there be more Wounded Knees?

✓RUSSELL MEANS: You see, the American Indian Movement, we do not have a strategy that plans, (quote unquote) you know, "actions". What we do is respond to Indian people. American Indian Movement has never gone any place that is un--not invited to. When Indian people have the feel that uh deprivation of their rights have been ostracized and and

bent out of shape and and and disregarded and and they call American Indian Movement for assistance, we respond. And if there is going to another Wounded Knee, there there better not be because the next Wounded Knee would--is going to be completely larger, because the Chicanos are with us, the Blacks are with us, and a lot of white people are with us.

ANNOUNCER: Now one of the things that disappointed uh me and disappointed many Chicanos was the fact that Senator MC GOVERN was supposed to be the champion of minority rights and of course there were press reports that Senator MC GOVERN had referred to you as a "rip off artist". What's your response to that?

RUSSELL MEANS: Well if I'm a rip off artist, 180 years in a Federal penitentiary uh in my in in my estimation is is you know, I should quit being a rip off artist.

ANNOUNCER: It's too expensive.

RUSSELL MEANS: You (unintelligible). With my uh, you know, with my life at stake and and uh you know, it's not mine, you know, there's there's over 300 defendants facing Federal prison terms.

ANNOUNCER: You know, one of the things that uh perhaps is critical is that everyone thinks that Wounded Knee is over,

it's not. Now, according to your attorney, MARK LANE, you're going to have a critical battle, a constitutional battle, and uh there're six major defendants and you're going to be tried early this coming year in the, in the Spring of 1974. What's the nature of your legal defense? What are the issues...

RUSSELL MEANS: Of the over 300 defendants that uh are presently facing Federal prosecution because of Wounded Knee, the first two that are going to trial are DENNIS BANKS and myself. We are scheduled for trial January 8th in St. Paul, Minnesota.

ANNOUNCER: Is that Federal court?

RUSSELL MEANS: Federal court.

ANNOUNCER: Do you face any state indictments at all?

RUSSELL MEANS: Uh yes, but these stemmed from the Custard incident of February 6th and uh sundry other incidents, when Indian people are fighting for their rights. You see, you have to understand, the State of South Dakota has has has uh uh such uh frontier mentality that it makes a JOHN BIRCH society and the Klu Klux Klan look like girls scouts. And uh the the fact that we we're going--now, you know, everybody's got to understand this in America, they've got to understand that. We are basing our defense in in the trials over Wounded Knee

on our treaties. If we are, by some remote chance, proved guilty, then that is saying the United States of America is saying that Indians do not have treaty rights...

ANNOUNCER: mmm hmm

RUSSELL MEANS: Senator SAM IRVING...stated to congress and he's the acknowledged constitutional expert of the senate. He stated that that treaties made by this country and ratified by congress, which our treaty is, is on par and equal to the constitution of the United States of America, and those treat-- and the law of the land is the constitution; therefore, those treaties supersede Federal state and local laws. Now, if they prove us guilty, they're saying Indian people to do not have treaty rights, They're also saying that everybody else doesn't have constitutional rights.

ANNOUNCER: Yeah, one of the things that interest me is uh the Wounded Knee Legal Offense Defense Committee. Can you give us the address of the committee?

RUSSELL MEANS: The Wounded Knee Legal Defense Offense Committee is presently headquartered in Rapid City, South Dakota, Box 991, Rapid City, South Dakota.

ANNOUNCER: What kind of assistance do you need?

RUSSELL MEANS: Financial

ANNOUNCER: Financial?

✓RUSSELL MEANS: We have expended over \$120,000 already, trying to bring up a legal defense for over 300 defendants. We estimate before it's all over we need another 1.2 million dollars, and that's Box 991, Rapid City, South Dakota.

ANNOUNCER: When do the other cases come up. I know the the major cases, yours and DENNIS BANKS is in January, but are the others going to be consolidated or....

RUSSELL MEANS: No, they've uh they've thrown two judges at us, and uh the ones that are nonconspiracy cases, other than the six major defendants...

ANNOUNCER: mmm hmm

RUSSELL MEANS: the other uh 300 or so defendants that are nonconspiracy cases are going to be trialed in Sioux Falls, South Dakota, by another judge...

ANNOUNCER: mmm hmm

RUSSELL MEANS: beginning in January.

ANNOUNCER: You know we have on the set uh and "Impacto" is primarily a Chicano - Hispano program but we have on the set a Cachina (ph) doll and uh maybe you could tell the significance uh to the viewers of the of the Cachina (ph) doll.

RUSSELL MEANS: I don't only only want to speak about the Cachina (ph) doll because a Cachina (ph) is a Hopi and this is my interpretation...

ANNOUNCER: mmm hmm

RUSSELL MEANS: It's a Hopi symbol of a messenger to the Great Mystery th-and that's the buffalo Cachina (ph)...

ANNOUNCER: It has a buffalo head, what's the significance of that?

RUSSELL MEANS: Uh I'm not a Hopi and and you know I I can not tell you the the express everything on that Cachina (ph) means something spiritually.

ANNOUNCER: Well what is the buffalo and and uh feathers, what does that to to Indians as well....

RUSSELL MEANS: Like like I wanted to relate that buffalo Cachina (ph) you know, is like this uh shield here, this war shield, it's a buffalo hide war shield with the eagle feathers. The buffalo, among the Lacota, which I am, the white man call us Sioux--uh I'm Lacota. The buffalo is the chief of all four leggeds and the eagle is the chief of all things that fly...

ANNOUNCER: mmm hmm

RUSSELL MEANS: And uh they're holy and sacred and and and those

eagle feathers are part and partial of prayer feathers--really uh or--you know, they have that symbolism...

ANNOUNCER: Uh huh

RUSSELL MEANS: And and they have power, spiritual power, as well as that buffalo hide and this why that is the strongest medicine right there and I know, you know, the non-Indians might look at us as primitive but that's the strongest medicine you can carry into battle right there.

ANNOUNCER: RUSSELL, do you fear--do you fear for your life because of what you've done? Do you receive threat....

RUSSELL MEANS: You have to understand uh you see, I've, I've been involved in the sacred sun dance of the Lacota and uh, you know, most prairie Indians, most plains' Indians have the sun dance, in fact all of them that I know of, uh have been involved in the sacred sun dance. When you take the sun dance vow, it goes for four years. I've one more year, next August I go into my last sun dance. I've no fear for my life until after I get through that sun dance, then I'm confident that the Federal government will uh off (ph) me...

ANNOUNCER: Have you received any threats...?

RUSSELL MEANS: Oh I receive them everyday, through the mail, on the telephone...

ANNOUNCER: RANDY, there's a local AIM committee, where can one reach them?

RANDY EDMONDS: They have an office uh at uh my center, uh the Los Angeles Indian Center and uh they can be reached at the Indian Center or they can contact uh we have a uh entering person there that can refer them to a uh uh one of the coordinators of the AIM movement...

ANNOUNCER: And you're listed in the in the white pages under the LA Indian Center?

RANDY EDMONDS: Los Angeles, well, it's the Indian Center Incorporated...

ANNOUNCER: mmm hmm

RANDY EDMONDS: it's 600 South New Hampshire, 382--what is it? 386-6262, I forgot my phone number

ANNOUNCER: Gentlemen I want to thank you very much. I know RUSSELL that your schedule is very hectic and we, here at "Impacto" uh really appreciate having you on the program and uh so the Chicano community and all of our (tape skips) about Wounded Knee and the critical issues at stake, especially with the Legal uh Offense Defense Committee--on behalf of our production....

RUSSELL MEANS: I would like to say one thing and leave the viewers with this question of what Chief SEATTLE (ph)

said after he surrendered to the white government, "Nation follows nation, and tribe follows tribe, it is like the waves of the sea, it is the order of nature and regret is useless. Your time of decay may be distant but it will surely come, for even the white man's God, who walked and talked with him, could not escape the common destiny. We may be brothers after all, we shall see.
